Valley Medical Transport (VMT) and Blue Ridge Community and Technical College (BRCTC) are thrilled to announce a new partnership that will bring a satellite campus to VMT's main location at 190 Prosperity Drive in Winchester, VA. This collaboration marks a significant step in VMT's commitment to offering high-quality, flexible, and engaging paramedic training to its employees and the wider community.

The comprehensive paramedic program will span 11 months, commencing on **October 20, 2025**. Classes will be held every **Monday from 9:00 AM to 5:00 PM**, supplemented by weekly assignments and online lectures. The curriculum also includes mandatory clinical hours, providing students with essential handson experience.

Applying for the program is the first step toward enrolling in this exciting opportunity.

Paramedic Information:

The Paramedic program equips you to be a vital part of emergency medical services, providing advanced life support to critically ill and injured patients. Through a combination of classroom instruction, lab simulations, and hands-on clinical rotations, you'll gain the knowledge and skills to assess patients, administer medications, manage complex medical emergencies, and transport patients to definitive care. <u>Upon successful completion of this Paramedic course</u>, a student will be <u>authorized to take the National Registry of Emergency Medical Technicians (NREMT) Paramedic cognitive examination</u>.

Mission Statement:

Blue Ridge Community and Technical College provides our diverse student population with lifechanging education, training and services that drive economic development within the communities we serve.

Course Format

Students enrolling in the program will have a structured weekly schedule. Every Monday, from 9 a.m. to 5 p.m., students are required to attend a lecture review and lab day. Beyond this fixed weekly session, students will also complete clinical rotations, which they'll schedule themselves based on available shifts. While most of the program adheres to this schedule, occasional weekends or additional days may be necessary, though these will be limited. A significant portion of the learning will occur through the Learning Management System, where students will access weekly online lectures and assignments. The program is designed to run for approximately 48 weeks (11 months), commencing on October 20, 2025, with a tentative completion date in late August 2026.

Course Requirements

Students must understand the academic and physical rigor including substantial time commitment that surrounds EMS education, technical standards, and certification/licensure. Successful completion of this course requires satisfaction of all Paramedic program requirements including affective domain, didactic (coursework), psychomotor (lab), high stakes examinations (FISDAP), and certifying body (CoAEMSP) requirements to include all required field/hospital clinical hours.

Students will submit the following documentation at the start of orientation into Castlebranch. **Failure to submit this documentation may result in dismissal from this program.** Additional paperwork and onboarding tasks will be completed during this time.

Step Three (Complete Castlebranch Requirements)

Upon receiving your program application form, you will be sent a dedicated CastleBranch link. This link is essential for submitting all necessary immunization and physical documentation required for the clinical components of your program.

Key Information:

- Due Date: All clinical requirements submitted via CastleBranch are due by October 15, 2025.
- CastleBranch Code Fee: Please be aware that if you utilize the CastleBranch code and then withdraw from the program before the first day of class, a \$200 fee will be charged to you.
- **COVID-19 Vaccination:** The COVID-19 vaccination is **not** a required immunization for this program.
